

## 482 Sponsorship Employer Guide & Document Checklist

### Skills in Demand Visa (Subclass 482) - Core Skills Stream

The **Skills in Demand (SID) Visa - Subclass 482** allows Australian employers to sponsor skilled overseas workers when they cannot find suitably qualified Australian workers. The process involves:

1. **Becoming an Approved Sponsor**
2. **Nominating a Position**
3. **Visa Application for the Nominated Employee**

## 1. Becoming an Approved Sponsor

### Eligibility Criteria:

- Be a legally established and actively operating business in Australia.
- Demonstrate a commitment to employing local Labor and non-discriminatory recruitment practices.

### Required Documents:

- **Australian Business Number (ABN) Registration Certificate**
- **ASIC Business Name Extract**
- **Financial Statements** (most recent fiscal year)
- **Business Activity Statements (BAS)** (last 4 quarters)
- **Organizational Chart** showing company structure
- **List of Employees** including roles and visa statuses
- **Lease Agreement** or proof of business premises ownership
- **Director's Identification** (e.g., driver's license, contact details)

**Note:** If your business is not yet an approved sponsor, you must apply for **Standard Business Sponsorship (SBS)**. Once approved, SBS is valid for 5 years.

## 2. Nominating a Position

### Key Requirements:

- **Occupation Eligibility:** The position must be on the **Core Skills Occupation List (CSOL)**.
- **Salary Requirements:** The nominated position must meet:
  - The **Annual Market Salary Rate (AMSR)**
  - Not less than the **Core Skills Income Threshold (CSIT)**, which is:
    - **AUD 76,515.00** for nominations lodged between 1 July 2025 and 30 June 2026
- **Labour Market Testing (LMT):** Evidence of genuine efforts to recruit Australian workers, unless exempt.

### Required Documents:

- **Employment Contract** for the nominee
- **Detailed Position Description** aligned with ANZSCO classification
- **Evidence of Labour Market Testing:**
  - Copies of job advertisements (at least 2 platforms, posted for a minimum of 28 days)
  - Summary of recruitment efforts and outcomes
- **Organizational Chart** showing the nominee's position
- **Business Premises Photos** (e.g., signage, work areas)
- **Market Salary Research** to substantiate AMSR

### 3. Visa Application by the Nominated Worker

#### Applicant Requirements:

- **Work Experience:** At least **1 year** of relevant work experience in the nominated occupation or a related field
- **English Proficiency:** IELTS **5 each** or PTE **36 each** or equivalent unless exempt
- **Skills Assessment:** *If required for the occupation*
- **Health and Character Requirements:** Undergo medical examinations and provide police clearances

#### Required Documents:

- Passport Bio Page
- Qualification Certificates
- Employment References
- Updated Resume/CV
- English Language Test Results (if applicable)
- Skills Assessment Outcome (if required)
- Health Examination Reports
- Police Clearance Certificates

## 5. Compliance Obligations

Employers must:

- Ensure the visa holder works only in the nominated occupation
- Pay the visa holder at least the AMSR and not less than the CSIT
- Notify the Department of Home Affairs of any changes in the employment situation
